The following information explains more about the issues you need to think about to choose your new name, as well as some information to help guide you through the process.

Before you make your choice:

- 1 You must have the words “Limited Liability Partnership” or the letters “LLP” at the end of your name.
- 2 You cannot use a name that has already been incorporated – you can check the register of companies and the register of limited liability partnerships at www.companieshouse.gov.uk. Even if the name is spelt differently, if it sounds the same you will not be able to use it, nor will you be able to use a name that is confusingly similar to one already in use. You may also want to check the trade marks register – if you register your limited liability partnership and somebody already owns the trade mark, they may sue you for passing off.
- 3 You can only use certain sensitive words if you fulfil certain statutory conditions, and have been granted permission to use the word. Some of the restrictions are straightforward, for example you cannot say you are Smith Europe Limited Liability Partnership unless you actually trade in Europe. Others are more obscure, for example, to use the word “Windsor” you need the consent of the Lord Chancellor, even if your business is based in Windsor.

- 4 You cannot use a name that may be considered offensive.
- 5 You cannot use a name that is misleading.

How to change your partnership's name:

- 1 Send form LLP3 to the Limited Liability Partnership Team, Cardiff, and the fee (currently £20)
- 2 All documents with the partnership's name must be changed including:
 - 2.1 partnership's headed paper;
 - 2.2 bills/invoices/receipts;
 - 2.3 long term contracts; and
 - 2.4 conditions of sale.
- 3 The partnership's new name must be displayed outside the partnership's registered office and any other places of business.
- 4 You must notify certain people of the change including:
 - 4.1 business associates such as bankers, solicitors;
 - 4.2 staff;
 - 4.3 suppliers; and
 - 4.4 utility providers.
